#### 6) Presentations (Members, Community, Etc.)

#### Yardhouse/BC

Tyler Booth presented on behalf of the Yardhouse/B3. They want to continue to partner with KMFA to offer programming, including skills workshops and sponsor KMFA youth who might have difficulty paying B3 fees to participate. The partnership would include working together to book field space and run programs. Other programming will likely include training for KMFA coaches.

A motion was made to continue to partner with the Yardhouse/B3 for athletic development activities that benefit KMFA athletes by Micha, seconded Erin. All in favour, approved.

#### **New Jerseys**

Bryan Thiessen presented mock-ups of new tackle jerseys for KMFA. The current inventory is old and includes the name of a previous sponsor who is no longer in business. The proposed jerseys will mirror the CJFL Okanagan Sun in name and colour to build community and connection. Jersey colours will be orange, white, black and grey.

A motion was made to have Bryan present to the Okanagan Sun board of directors that KMFA start going by the Kelowna Sun and ask if we can use the Okanagan Sun logo on the arm of the jersey by Micha, Mat seconded. All in favour, approved.

#### 7) Continued Business:

#### a) <u>Financials Update</u> - Clarke

- i) Approximately \$58,839 in the general account and \$41,356 in the gaming account. Not many expenses since financials were presented at AGM.
- ii) The President forwards invoices to the Treasurer to review and create cheques. Two signatures are required on each cheque.
- iii) The former vice-president is being removed from the bank account, and the newly elected vice-president is being added.
- iv) All financial statements are saved on the KMFA Board of Directors shared drive.

- v) Clarke would like to do e-transfers to pay referees in 2025. Will contact our financial institution to set it up.
- vi) A Stripe account was created to accept payments via our new registration platform TeamLinkt.
- vii) KMFA will keep a small balance within the Stripe account to allow us the ability to perform refunds if they are needed throughout the year.

#### b) Winter Flag Committee

- i) Very positive feedback on TeamLinkt from membership. Cherisse found the system great to work with from registering kids to assigning teams after the draft.
- ii) U10 39 (four teams), U12 62 (6 teams), U14 68 (6 teams), U16 45 (4 teams)
- iii) Evaluations & teams drafted Jan 5 and Jan 6 went really well. Thanks to everyone who helped move equipment, setup, run stations, etc. All four sessions went off without any issues.
- iv) Jerseys & shorts might arrive by January 10. All items will be distributed by January 18 and 19.
- v) Referee training was held January 3 at the Yardhouse. Well attended and many new referees to support our programs. Referees will be invited to practice with the U16's at their January 12 session.
- vi) There are a few rule changes, coaches will be sent an update and a coaches meeting will be held.
- vii) Plan to host a pre-game coaches meeting the first week of games to review rules, set the tone for games and interactions with the referees, and address any questions.

b) Spring Flag Committee

- i) Spring flag runs for 8 weeks. It starts April 6 and the final games will be held Friday May 30 to Sunday June 1.
- ii) Spring flag runs through Easter weekend, but will not run on May Victoria Day long weekend (May 18)
- iii) Practices are up to twice a week, up to 2 hours per practice schedule at the coaches discretion Monday Friday. Locations TBD.
- iv) Booking of field space for practices contacting City of Kelowna and SD23 to discuss options.
- v) Games: Sundays U16's 8am 10am, U14's 10am 12pm, U12's 12:15pm 2:15pm, U10's 2:30pm 4:30pm

vi) Registration

- 1) In 2024 we had Little Tykes-22 players, U10-93 players (10 teams), U12-125 (14 teams), U14-94 (10 teams), U16-44 (4 teams).
- 2) Opening caps to 192 per age group in 2025.
- 3) Cost \$100 Little Tykes, \$200 for all other ages plus association fees..
- 4) Open registration by the end of January.

- viii) Coach recruitment will start soon.
  - ix) The BCPFA spring flag provincials are being held June 7 & 8 in Kamloops. Coaches can submit a team, any mix of KMFA players per age group.
  - x) Joe Gluska Tournament June 13, 14, 15 and 7's tournament June 20 & 21 will not impact spring flag.

i) Working on creating a helmet purchasing schedule so that every 7 years, we retire a set of helmets and purchase replacements.

#### d) <u>Coaches & Player Development Committee</u>

i) 20 coaches were recruited and confirmed to support winter flag program. Working on confirming credentials.
